Background & objectives

Background

- In Hong Kong, no matter in what legal form NGOs exist, there is no legal compliance requirement for them to publish annual reports.
- Nevertheless, annual reports are one of the most popular channels of communications and disclosure among agencies in the social service sector.

Objectives

This is an exploratory research that aims at studying the contents of social service organizations' annual reports and shedding lights on good practices in compiling the reports for effective communication with agencies' stakeholders.


- The remaining was not surveyed due to the below reasons:




Scale (in terms of size of annual recurrent expenditure)



Type of incorporation




